Tanvir Bajwa, MD

Dr. Tanvir Bajwa is a highly accomplished Milwaukee-area physician, best known for his technical expertise in advanced interventional cardiac, peripheral vascular and structural heart disease procedures. He has participated in and designed several scientific research protocols to treat such conditions as peripheral vascular disease, renal artery disease, abdominal aneurysms and carotid artery disease. Dr. Bajwa serves on the faculty at Aurora Sinai Medical Center in a variety of appointments, including Associate Head, Cardiovascular Disease Section; Director, Cardiac Catheterization Laboratory; and Director, Peripheral Vascular Laboratory.



Atul Bhatia, MD

Dr. Bhatia was the first electrophysiologist to implant a "combo" device (combination defibrillator and biventricular pacemaker) in South Asia. After earning his medical degree in India, Dr. Bhatia came to the U.S. where he completed fellowships in both cardiovascular disease and clinical cardiac electrophysiology through the University of Wisconsin Medical School's Milwaukee Clinical Campus at Aurora Sinai Medical Center. Dr. Bhatia is a fellow of the American College of Cardiology and the Heart Rhythm Society, and is a member of the American Heart Association



Eric Stilp, MD

Dr. Stilp earned his medical degree at George Washington University School of Medicine, Washington D.C., in 2006.
